#### March 11, 2025

# **Chair Introductions to Oregon Council Members**

## **Council Meeting Agenda Items**

# 1. Proposed Reference Plants for the Ninth Plan (Part 2)

Resource Policy Analyst Annika Roberts provided a follow-up presentation to the February Council meeting, where staff began the process of reviewing proposed reference plants to be analyzed in the Ninth Plan. During this presentation, Roberts outlined details of each reference plant. This included costs, availability, and timing for each resource. The presentation also incorporated feedback from the Generating Resource Advisory Committee.

# 2. Proposed Conservation Resources Part 1

Power Planning Resources Manager Kevin Smit and Senior Resources Analyst Christian Douglass presented on energy efficiency and how this resource is defined for the purposes of building it into the Council's modeling ecosystem. This presentation included a background on energy efficiency; what's new for energy efficiency in the Ninth Plan; and a summary of the status to date (including the public review process). Over the next few months, Power staff will be finalizing all the energy efficiency supply curves. These supply curves will then be used by staff as inputs to the OptGen model to ultimately be compared alongside generating resources.

#### 3. Ninth Plan Demand Forecast Part 1

Senior Energy Forecasting Analyst Steve Simmons and Senior Power Analyst Tomás Morrissey presented a framework for the Ninth Plan demand forecast. Power staff outlined three goals for the forecast, including creating an accurate and comprehensive long-term forecast of demand for the region, delivering an informative set of inputs to the power planning models, and developing a spread of potential future demand trajectories and characteristics.
