September 9, 2025

Council Chair Mike Milburn brought the Council Meeting to order at 8:30 a.m. Pacific Time. Council Members Jeff Allen, KC Golden, Doug Grob, Margaret Hoffmann, Thomas L. (Les) Purce, and Ed Schriever were in attendance in person. Charles F. Sams III was not in attendance. The next Council meeting is scheduled for October 14-16 in Tamarack, Idaho, and via webinar.

Report from the Executive Director and State Updates

Executive Director Peter Cogswell reflected on his family history in Eugene, OR, spoke about the Finn Rock and Quartz Creek field trip on September 8th, briefly recapped the Congressional tour, and shared updates, including a presentation to PNCG and upcoming Council performance reviews. Member Purce shared his concern about wildfires in the northwest, as well as his interest in gaining more insight into data centers and their usage of energy and water. Member Grob shared that Chair Milburn will be the guest speaker at the Montana Electrical Co-op Association. Chair Milburn highlighted that Member Sams is absent from the meeting as he is in Washington D.C receiving the Lone Sailor Award. Member Hoffmann also acknowledged Member Sams and his contribution to the United States.

Council Meeting Agenda Items

1. Dr. Debbie Colbert, Oregon Department of Fish and Wildlife (ODFW) Director

Member Hoffmann introduced Dr. Debbie Colbert, Director of Oregon Department of Fish and Wildlife, to brief the Council on her tenure with ODFW and share the challenges and status of fish and wildlife management in Oregon. Dr. Colbert shared an overview of ODFW's work to protect and enhance Oregon's fish and wildlife and their habitats for the benefit and enjoyment of present and future generations.

2. Restoring Ecosystem Processes and Fluvial Functions at Meaningful Scales in the Upper Willamette Basin, including the McKenzie River

Fish and Wildlife Policy Analyst Rudy Salakory introduced Joe Moll, Executive Director, McKenzie River Trust and Susan Fricke, Water Resources Supervisor at the Eugene Water & Electric Board (EWEB), to provide the Council with an informative overview of the work supported by the Council and Bonneville Power Administration on the McKenzie River and its tributaries over the past 20 years; efforts implemented from the mouth to the headwaters of the McKenzie River. Moll and Fricke discussed the evolution of increasingly complex, large-scale land protection and habitat restoration initiatives, as well as the successful partnerships that have made this work possible.

Director of Power Planning Jennifer Light provided an update on the Power Plan timeline and next steps in the scenario and analytical modeling phase.

4. Finalizing Scope of the New Resource and Transmission Risk Scenario

Director of Power Planning Jennifer Light presented an update on the New Resource and Transmission Risk Scenario being developed for the Ninth Power Plan, which will examine uncertainty around the future availability and cost of new resource additions and transmission. She reviewed the six sensitivities that the Council had previously agreed to model during the

February 2025 meeting. Director Light shared further details on the proposed sensitivities and sought general support from members on the overall scope of the analysis.

5. 2024 Regional Conservation Progress (RCP) Results

Regional Technical Forum Manager Laura Thomas presented the 2024 RCP survey results tracking the region's progress toward the energy efficiency goals outlined in the Council's 2021 Power Plan. She explained that the RCP, conducted annually by the Regional Technical Forum on behalf of the Council, collects data on energy efficiency savings and expenditures across the region. Thomas shared that the 2024 report marks the third year and halfway point of the six-year action plan, which set a goal of acquiring 750 to 1,000 aMW of cost-effective conservation by 2027. She noted that the report includes data from Bonneville and its customers, the investor-owned utilities in the region, the Energy Trust of Oregon, and the Northwest Energy Efficiency Alliance (NEEA), and helps track how well the region is meeting both savings targets and broader conservation program goals.

Council Members, General Counsel John Shurts, and staff discussed the following topics: the Program vision and science principles, goals and objectives, wildlife, predator management, non-native and invasive species, ocean, and artificial production.
