## **Council Meeting Summary** **December 16, 2025** **via Webinar**

### **December 16, 2025**

Council Chair Mike Milburn brought the Council Meeting to order at 8:59 a.m. Pacific Time. Council Members Jeff Allen, KC Golden, Doug Grob, Margaret Hoffmann, Thomas L. (Les) Purce, Charles F. Sams III, and Ed Schriever attended virtually. The next Council meeting is scheduled for January 13, 2026, in Portland, OR.

### **State updates**

Member Sams shared that Oregon members met with the Columbia River Inter-Tribal Fish Commission (CRITFC) to share a Council update.

### **Council Meeting Agenda Items**

#### **1. Decision to release the draft amended Columbia River Basin Fish and Wildlife Program**

Fish and Wildlife Division Director Patty O'Toole began the presentation with a process check-in and discussion on the draft amended Program. Director O'Toole then proposed the Council consider two related decisions: a decision to release the draft amended Fish and Wildlife Program for public review and a decision on the length of the review period.

## **Motion to approve the release of Draft 2026 Fish and Wildlife Program amendments for public review and comment**

Member Purce moved that the Council approve the release of the Draft 2026 Fish and Wildlife Program for public review and comment through March 2, 2026, as presented by staff [with changes made by the Members at today's meeting].

Member Grob seconded.

Member Schriever began a discussion on the 75-day comment period and the timing of the March Council meeting and also offered consideration of a 90-day period. Members and staff continued discussion.

Voice vote - all in favor, none opposed the original motion with the comment period ending March 2, 2026.

Motion was approved.
