SUBJECT: Council Budget Process Report to Congress

## **Background:**

The Congressional House Appropriations Committee has included language in the report that accompanies the Energy and Water Appropriations bill that requests the Council to provide information on its most recent budget formulation. Because the Council is funded from Bonneville ratepayer revenues, the committee questions whether the Council's independence is diminished in matters pertaining to major capital funding decisions by Bonneville.

The report was due by November 1<sup>st</sup> however, since the legislation has passed the Committee but not yet been passed out of the House, the due date has been deferred until the end of November.

Council staff is working on the draft report. It will be sent under separate cover when it is completed prior to the Council meeting.

## Action:

At the Council meeting, staff will review the proposed organization and content of the report. While the committee requested budget formulation information, staff believe this is also a unique opportunity to attempt to resolve problems with the funding formula that frequently disadvantage the Council's independent planning capability. Information will be proposed for inclusion in the report that addresses this issue.
