SUBJECT: Snake Hells Canyon Subbasin Contract Amendment

Proposed Action

Staff recommends the Council authorize the Executive Director to negotiate an amendment to contract number SSII47 with the Nez Perce Tribe (NPT) to supplement the development of the Snake Hells Canyon Subbasin assessment. The attached proposal outlines the additional work that will be accomplished under this amendment. The existing contract is for \$163,430. The amendment will increase the budget by \$40,000 for a total project cost of \$203,430.

Background

The Snake Hells Canyon Subbasin is shared by the states of Idaho, Oregon and Washington. Idaho Level II group has the lead on this subbasin and all three states agreed that the NPT be awarded the contract to develop the subbasin plan. The Idaho Level II allocated \$105,000; Oregon Level II allocated \$33,794; and Washington Level II allocated \$24,636 to the contract. Idaho Level II approved an additional \$40,000 from the Idaho Level II technical budget for the Snake Hells Canyon contract to provide for more in-depth use of Idaho Power Company data, Qualitative Habitat Analysis and use of The Nature Conservancy (TNC) SITES model to improve the assessment. Proposed Schedule and Budget

The proposed budget increase will not exceed \$40,000. All work associated with this contract will be complete by May 28, 2004.

- 3. Expand efforts to address economic and social issues in subbasin plan.
- 4. Run SITES model to identify areas of particularly high biodiversity.
- 5. Improve utility of available GIS for use in subbasin planning, work to resolve data inconsistencies between three states.
