Kootenai Subbasin - Development of Qualitative Habitat Assessment for Lakes Contract Number: SSIM31 Amendment #3

Introduction and Background

The Flathead and Kootenai subbasin planners are using Qualitative Habitat Assessment (QHA) to assess streams in the subbasins based on key habitat attributes. QHA was designed specifically for resident salmonids in streams. The QHA methodology is currently being refined and applied to numerous subbasin planning and assessment activities for almost all of the Columbia Basin Provinces and will serve to quantify and complete assessments. However, it is not currently geared to assess habitat attributes of lakes and reservoirs. Focal species for the Kootenai and Flathead subbasins include bull trout and westslope cutthroat trout; both of which have adfluvial life histories. This proposed work will help finalize the development of a lake version of QHA (LQHA) that can be used by other subbasin technical teams with reservoirs and lakes in the Columbia.

Dr. Paul Anders, through a subcontract with the Kootenai Tribe of Idaho (KTI) is able to assist in the development of LQHA in consultation with the model developers -- Chip McConnaha of Mobrand Biometrics, and Drew Parkin, Council subbasin planning contractor. Dr. Anders will build on the framework of the stream version under the existing KTI contract and with additional funding through this amendment.

Dr. Anders will perform the tasks below consistent with the Council's Subbasin Assessment Template. These tasks will result in a tool that will allow a classification of large lakes and reservoirs in the subbasin, which is necessary for completion of the assessments for both the Flathead and Kootenai Subbasins.

Tasks

- 1. Meet with the creators of QHA (Drew Parkin and Chip McConnaha) to plan and coordinate development of a LQHA spreadsheet tool.
- 2. Identify key habitat attributes and biological and management factors important to resident salmonids in lake and reservoir environments.
- 3. Collaborate with Chip McConnaha to convert the stream version of QHA into a lake version (LQHA) by substituting lacustrine attributes for the stream habitat attributes and by making other conversions and adjustments as necessary.
- 4. Test the lake version using Lake Koocanusa or Flathead Lake.
- 5. Add a LQHA chapter to the existing QHA user's guide.
- 6. Attend and participate in at least one technical team meeting each in the Flathead and Kootenai Subbasins when those teams use the LQHA and provide instruction on the tool's use and fix any problems.

7. Provide follow-up assistance as needed to the Flathead and Kootenai Technical Teams.

- 1. A lakes version of the QHA spreadsheet.
- 2. A description of the methodology (lakes chapter to QHA user's guide)
- 3. Brief written summary of assessment meeting results and follow-up technical assistance..
