This letter is to notify you of the following:

- 1. Bonneville Power Administration's (BPA's) decision to fund all qualifying rescheduling requests as recommended by the Council on Feb 27, 2004.
- 2. BPA's decision to fund a within year budget increase request for CBFWA's annual work plan as recommended by the Council on February 27, 2004.
- 3. BPA's request for the Council's recommendation on funding selected critical, within-year (FY04) budget increase requests.

A recently completed internal budget analysis resulted in a BPA decision to fund all qualifying rescheduling requests received as of April 20, 2004. Enclosure 1 lists all funded rescheduling requests.

Additionally, the analysis identified funds available to proceed with a few of the most critical, within-year budget increase requests. After BPA internal review and consultation with the Budget Oversight Group (BOG), the within year requests determined most critical are listed at enclosure 2.
