## **MEMORANDUM**

**SUBJECT:** Planning for Possible Power Committee Site Visits

Power Committee members have expressed an interest in arranging site visits to a number of energy facilities that hold potential for electrical generation alternatives in the Council's power plan. The suggested visits included the following:

- Genesee 3 new supercritical coal-fired steam-electric plant near Edmonton, Alberta
- Alberta Oil Sands extraction and processing facilities cogeneration of electricity, Ft McMurray, AB
- Great Plains Synfuels Plant coal gasification (no power production) with CO<sub>2</sub> separation, Beulah, ND
- Weyburn-Midale CO<sub>2</sub> Project enhanced oil recovery with CO<sub>2</sub> injection, Weyburn, SK (research project headquartered at University of Regina)
- Raft River Geothermal Project binary cycle geothermal power plant (under construction), Cassia County, ID
- INEEL advanced nuclear reactors, hydrogen cogeneration demonstration project (discussion, no projects as of yet), near Idaho Falls, ID

There was discussion that the Council might be able to schedule tours of these facilities around Council meetings in the vicinity. However, it seems that all of these sites are sufficiently remote from Council meeting locations that there may not be a large advantage to limiting visits to occur next to Council meeting.

It would probably make sense to combine some of these tours. The first two would fit together, as would the second two, and the last two. Each tour could require at least a few days counting travel.

Jeff King put together some initial information and possible contacts for these facilities. They are attached. The Power Committee will discuss how, and I hope whether, to pursue these site visits.
