- **SUBJECT:** Renewal of charters for the Conservation Resources Advisory Committee, Generating Resources Advisory Committee, System Analysis Advisory Committee, and Demand Forecasting Advisory Committee

Staff will ask the Council to authorize the renewal of the following charters which have expired or are about to expire.

- Conservation Resources Advisory Committee
- Generating Resources Advisory Committee
- System Analysis Advisory Committee
- Demand Forecasting Advisory Committee

The renewal term for each of the advisory committee charters is two years.

A decision memorandum authorizing renewal of each of the charters is included in the Council packet.

The charter provisions remain largely the same as those of the expired/expiring charters. The charters have been updated to reflect a more uniform approach to charter language in terms of incorporating provisions of the Council's policy on advisory committees and applicable provisions of the Federal Advisory Committee Act. Each charter has also been updated to reflect any changes to staff estimates of the advisory committee's frequency of meeting or annual operating costs.
