

The City of Bonners Ferry offers water, sewer, garbage and electricity to the residents in its service area. The utility services are operated as non profit enterprises, with the goal of providing the best possible service at the lowest cost to the consumer.

Electric Department

The City of Bonners Ferry Electric Department is a municipal electric utility governed by the Bonners Ferry City Council and owned by the City since the 1920s. The City serves just over 2,400 customers, sells around 64,000 megawatt hours per year, with an annual budget of just under \$5 Million per year.

The electric department has four lineman, three power plant operators, and an electrician.

The City owns and operates the Moyie Hydroelectric

process which generates approximate 1/3 of its customer's electricity requirements. The remainder of the power is purchased from Bonneville Power Administration (BPA). The City currently has contracts with BPA extending through 2018.

Water and Sewer Department

Water for the City is provided primarily from Mrytle Creek, which provides excellent tasting water for our customers. The Kootenai River is used as a backup source, and we are also interconnected with the Cabinet Mountain Water District as an emergency back-up source. The water treatment plant uses rapid sand filtration, and we have three storage tanks with a combined capacity of 950,000 gallons. Waste water is treated in a four cell lagoon system.

Description of Services

IDAHO COUNTY LIGHT & POWER provides electrical distribution service to North Central Idaho. The cooperative is headquartered just east of Grangeville, Idaho on Highway 13. History

Incorporated in 1938, the cooperative's twelve original incorporators took advantage of one of President Franklin D. Roosevelt's "New Deal" programs to electrify the rural areas of Idaho County.

The cooperative's first 60 homes were energized in September of 1939. Today, the cooperative serves over 3,000 homes, farms and businesses located in the mostly unincorporated areas of Idaho County and southern Lewis County. The Cooperative also serves the City of White Bird and sections of the City of Kamiah.

In 1996, in order to be more responsive to consumers' needs and to be more flexible www.iclp.coop/info2.html

in a rapidly changing industry, the cooperative's Board of Directors approved the refinancing of the co-op's debt with funds from the private sector. This ended a fifty-seven year association with the Rural Electrification Administration and its successor the Rural Utilities Service. They then set a course of creating a diversified cooperative, one that could offer additional energy services and energy related services to our region.

In July of 1997, the cooperative began offering propane service to the cooperative's membership and to the neighboring communities of north central Idaho. As of January 1, 2003, this successful business was split-off from the cooperative into a forprofit corporation. The new corporation, "ICP, Inc.", continues to provide propane services to North Central Idaho. ICP is a wholly owned subsidiary of the cooperative. Kootenai Electric Cooperative, Inc. (KEC) is a member-owned electric utility in Hayden, Idaho. The Cooperative provides competitively priced, quality energy services to its members and is governed by an independent seven-member elected Board of Directors. Kootenai Electric has more than 22,000 member accounts and nearly 2,000 miles of electric line in parts of Kootenai, Benewah, Bonner and Spokane counties. Kootenai Electric employs 75 people and is the largest electric cooperative in Idaho.

KEC purchases all the electricity it sells from the Bonneville Power Administration. Kootenai Electric is a private, nonprofit electric utility owned by the members it serves. We sell power at cost. In the early 1930s, prior to the establishment of electric cooperatives like KEC, nearly 90 percent of rural America was without electricity. While more populated areas had power, it was not cost effective for investor-owned electric utilities to bring power out to the rural areas. In 1936, Congress acted by creating the Rural Electric Administration. The agency offered the loans to rural citizens wishing to form locally-owned electric cooperatives. On May 19, 1939 KEC began supplying power to 385 members. Since then KEC has been steadily growing and provides power to our member owners the Cooperative Way.
