**SUBJECT:** Annual Council/RTF Conservation Achievements Survey

Every year, in accordance with its Charter, the Council's Regional Technical Forum (RTF) conducts a survey of conservation savings and expenditures by utilities, the Energy Trust of Oregon, Bonneville and the Northwest Energy Efficiency Alliance. This year we will collect actual conservation savings and expenditures data for 2012 and as well as projected savings and expenditures for 2013 and 2014. The Council is targeting a November 2013 release date for the report on 2012 accomplishments and projections for future years.

The survey is voluntary. It relies on utility and agency staff to gather, submit and verify the requested data. Last year, with the assistance of the Pacific Northwest Utilities Conference Committee, 92 utilities and the Energy Trust of Oregon (representing over ninety percent of the region's retail electricity sales) responded to the survey. At the PNUCC meeting on July 12, 2013, Charlie Grist and Gillian Charles provided a briefing on the plan for collecting and reporting the data and once again asked for assistance in encouraging utilities to complete the survey.

At the September Council meeting, staff will brief the Power Committee on the survey process so that members are better able to respond to questions they may receive regarding its purpose and use.

#### Overview

- Publish report in November (estimate)
- Not a regulatory filing
  - » Utilities chose how and what to report
  - » Council/RTF staff does not vet reported data







#### Review 2011 Report Findings & Forecast


- Requested Actual Conservation Savings and Expenditures for 2011
- At the request of PNUCC, also requested Projected Savings and Expenditures for 2012 – 2014 to compare against 6th Plan's targets
- Total Savings 277 average megawatts (including NEEA)
- Utility expenditures \$460 million (2011\$)
- Levelized utility cost about \$20 per MWh























## 2012 Survey

- Used the automated Planning, Tracking, Reporting (PTR) system
  - Regional Conservation Progress (RCP) report
- Public utilities data pre-populated from PTR, IOUs entered data from scratch

- Council is contracting with Synergy to resurrect the RCP portion of the PTR system on new eConservation platform
- Staff working with BPA to pre-populate the FY2012 data
- Similar process to past years, but slightly different look
