SUBJECT: Regional coordination forum

BACKGROUND:

Presenter: Lynn Palensky

Summary: The first regional coordination forum meeting is scheduled for March 19,

2015 from 9:00 a.m. to 4:00 p.m. Regional coordination representatives and other interested parties will discuss the upcoming years' issues of

regional significance with Council members and staff.

Attached is a draft agenda for the regional coordination forum (RFC). Generally, staff proposes to spend the first half of the meeting dedicated to discussing the priorities for the council and providing updates on some of the new initiatives. Part of the morning session will focus on updating the list of "Council's current and anticipated priority coordination work for FY2013-2014" from the Council's July 10, 2012 decision on regional coordination work (Attachment 1, Table 1). A draft revised list for 2015-2016 follows (Table 2). The second half of the meeting would be dedicated to topics suggested by the fish and wildlife managers. Suggested topics may be introduced ahead of or during the meeting.

Relevance: The RCF allows the Council to engage with the fish and wildlife managers

in a way that allows focus and dialogue on the Council's and division's priority fish and wildlife work. It also provides a forum in which the managers can convey other issues of regional importance. The meeting

Work plan:

This work is being tracked in the annual Fish and Wildlife Work Plan and the regional forum to discuss work priorities and will help inform the Division's annual work plan.

Background: The previous members of the Columbia Basin Fish and Wildlife Authority (CBFWA) for years, together, developed an annual work plan for implementation. While CBFWA no longer exists, the former members are still interested in assisting the Council in developing annual priorities of regional significance. The format will be different in that it will focus on larger, programmatic issues vs. implementation at a project level. However, it will help both regional coordinators and the Council to plan anticipated work load for staff each year.

> Annually, the Council will convene a forum of regional coordination representatives and other interested parties to discuss the upcoming years' issues of regional significance that may include:

- Council-sponsored/requested topical science and policy forums. workgroups, and special panels to aid in program development and implementation
- Ongoing work to improve program reporting, evaluation, and assessment
- Key program-related regional forums where policies, programs, and actions affecting fish and wildlife are planned and implemented
- Coordination of subbasin or other level program activities The Council will factor in the implementation priorities and its fish and wildlife program work plan into this annual discussion forum.

Program coordination funding

Entities receiving program coordination funding must participate in the annual forum and a subset of the resulting priority activities identified by the group, as appropriate for the particular entity. All related work should focus on activities that inform the Council on policy, program performance evaluation, and implementation decisions and are beneficial at a basinwide or regional scale.

All entities receiving funding for coordination of program activities must develop a work plan detailing the coordination elements, objectives, deliverables, and budget, as well as submit annual reports on this work, based on the upcoming year's priorities as outlined in the annual forum.

A. Council's current and anticipated priority coordination work for FY2013-2014

Table 1 lists what the Council believes are the priority needs for program coordination for the next two years, FY2013-2014. In other words, these activities are well-suited for program-level regional coordination funding since the Council will need the assistance from partners throughout the region. All of the work below is intended to be of benefit at a basinwide or regional scale and should inform the Council for policy, program performance evaluation, and implementation decisions. In contracts, coordination needs for individual projects should be funded from project budgets.
