## **BACKGROUND:**

Presenter: Lynn Palensky

Summary: The first regional coordination forum (RCF) meeting was held on March

19, 2015. Council members, Council staff, and regional coordination representatives focused the discussion on priority program work listed in the Council's draft work plan and on pages 114-117 of the program (see attached) and other issues of regional importance. Relevance: The RCF allows the Council to engage with the fish and wildlife managers

Background: Excerpt from the Council's Recommendation for Regional Coordination Projects - July 10, 2012 Decision:

C. Council recommendations (1) Priority Coordination Work: The Council recommends that Bonneville use the list of work functions and work products in Table 1 above as the basis for developing contracted scopes of work with associated funding for regional coordination. This list of priority work needing regional coordination is intended to be of benefit to the Program at a basinwide or regional scale and should be developed to inform the Council for policy and implementation decisions. This list should be reviewed and updated every two years. The Council does not expect that each entity funded will have interest, time or financial resources to participate in all the activities in this list of Council priority work (Table 1). The Council does expect that the entities receiving coordination funding use their coordination funding to participate in activities on the list (Table 1). In other words, each organization should undertake a subset of the work identified in Table 1, at their discretion, and with the funding received for regional coordination work. This work should be stated as specifically as possible in the contract scope of work. Council recommendation: All work indentified in a regional coordination project scope of work should originate from Table 1.
