BACKGROUND:

Summary: Bonneville has conducted a series of meetings and listening sessions as part of its Focus 2028 project. The sessions discussed Bonneville's role in energy efficiency and the structure and funding of its programs. Allison Mace will brief the Council on the major themes

Relevance: Bonneville's approach to energy efficiency has direct impact on the

Seventh Plan conservation goals and action Items. Findings from these discussions may influence Bonneville's upcoming proposal for it Integrated

Program Review (IPR) leading up to the rate case for 2018.

Workplan: A. 1. Conservation

Background: Most of the discussions to date have focused on energy efficiency.

Customer utilities of Bonneville and Public Power Council were the

primary participants. At this point Bonneville is seeking input and potential

solutions to the following topics:

- 1. How to align efficiency incentives with tiered rates?
- 2. Improving how BPA accounts for the benefits of efficiency, not just the cost
- 3. Should BPA consider alternative needs-based methods for determining its share of the Council's target?
- 4. Should BPA increase the self-funding percentage from 25% and, if so, should BPA revisit its backstop role?
- 5. How can BPA improve program design and efficiencies?

High Level Themes


Customers:

- Flat or shrinking load and challenging economic conditions for many customers
- Customer support for a three-pronged "public power proposal"

Constituents:

 Concern about making near-term changes to Bonneville's EE program in the context of a long term (2028) effort

What Have We Heard: Incentives for Utility Investment



Incentives for Utility Investment

Customers:

- BPA should not provide incentives for utilities to acquire resources they do not need
- Providing incentives to one group of customers may create an imbalance and cost shift

Constituents:

- Yes, BPA should look at innovative ways to encourage conservation
- Acquiring EE still makes sense for all customers as it reduces end user bills, even if rates increase

What Have We Heard: Improving the Accounting for EE



Improving the Accounting for EE

Customers:

 Full costs and benefits exploration could be included in future needs analysis

Constituents:

 BPA should compare the costs of today's system to costs the region would have faced in absence of conservation

Target Setting


Customers:

 BPA should develop a target through an open "analytically rigorous process" to assess BPA and customer needs

Constituents:

 BPA should adopt 42% of the Seventh Power Plan goals as its target

What Have We Heard: Self-funding and BPA's Backstop



Self-funding and BPA's Backstop

Customer perspectives:

- BPA should examine increasing the self-funding percentage
- Some customers would likely do a high level of self-funding, others may do less

Constituent perspectives:

 BPA should fund 100% of the defined target (no self funding)

What Have We Heard:

Program Efficiencies



Program Efficiencies Specific Input

Customer Perspectives:

- Focus on market lag in many areas
- Seek efficiencies in transactional nature of program
- Serving the moderate income population
- Establish mechanisms for trading of EE and incentives

Constituent Perspectives:

- BPA should undertake the Seventh Power Plan action items before changing implementation structure
- Establish mechanisms for energy efficiency trades
