- SUBJECT: Discussion of the Program Implementation Assessment

BACKGROUND:

- **Presenter:** Laura Robinson, Program Liaison Coordinator; Patty O'Toole, Program Implementation Manager
- **Summary:** Fish and Wildlife staff are compiling information on the implementation of each of the Program's 22 strategies into Program implementation summaries. These summaries will update the Council and the region on the status of each strategy's measures. Being roughly half-way through the implementation phase of the 2014 Program, these summaries will both show the work that has been done over the last 3 years, and help tee up discussions and work needed in preparation for the next Program amendment process. The Program Implementation Assessment, which will be a package made up of all summaries, is planned to be complete and provided to the Council this summer. At the June committee meeting, staff will provide an update on the progress of the summaries.
- **Relevance:** The Program Implementation Assessment will lay out significant developments on Program measures that have occurred since the adoption of the 2014 Program.
- Workplan: 2014 Fish and Wildlife Program Implementation

Background: The 2014 Columbia River Basin Fish and Wildlife Program was adopted by the Council in October 2014. Staff is planning for the next Program amendment process, which will likely begin in November 2018 and conclude in August 2020. The Fish and Wildlife Committee saw an example summary, focusing on the Wildlife Mitigation Strategy, at the May committee meeting. Staff is planning for all other summaries to follow that model. These summaries are intended to be snapshots of the most recent work completed for each strategy. Staff is working to keep each summary to two pages in order to make these easily digestible.
