About NRU


- Northwest Requirements Utilities (NRU) is actually a family of organizations
- Northwest Irrigation Utilities (NIU) was formed first, in 1985
 - Represent irrigation utilities (discount)
- NRU was founded in 2002 to aggregate and represent the interests of Full Requirements utilities
 - Now Load Following
- NRU LLC was formed in 2007 to create a framework to pursue non-federal options for Above High Water Mark loads under the Regional Dialogue contracts and provide other services to members on an as needed basis
- Northwest Energy Management Services (NEMS) was formed in 2009 as the administrative body for:
 - Northwest Energy Services Cooperative (NESC)
 - Northwest Intergovernmental Services (NIES)

Our Mission


- NRU advocates on behalf of its members for cost-effective and reliable wholesale power supply and transmission service (including transfer service) from BPA.
