- SUBJECT: Fish and Wildlife Program amendment: Discussion on Part I of the Program Addendum

BACKGROUND:

- Presenter: Leslie Bach and Patty O'Toole
- **Summary:** Staff will provide an update on the ongoing process of refining the program goals, objectives and strategy performance indicators. They will discuss the current status of revisions to the Part I document and provide a summary of the discussion and outcomes from the goals and objectives workshop and the strategy performance indicator workshops completed to date.
- Relevance: The Council is currently in a Program amendment process
- **Workplan:** Amending the Fish and Wildlife Program is described in the Fish and Wildlife Division Workplan.
- **Background:** During the public comment period on the draft 2020 Addendum, the Council received comments from some of the state fish and wildlife agencies and tribes asking the Council not to adopt Part I. They asked the Council to begin a process to work together to determine the most appropriate goals, objectives, and indicators for the program. At the December Council meeting, the Council members made a decision to extend the time for completing Part 1 of the program addendum and

approved a workplan proposed by staff. This plan includes a set of workshops to refine and revise the program goals, objectives and strategy performance indicators. A draft schedule was provided in the December packet memo. A revised list of the workshop dates is provided below. All workshops will have webinar/call-in options. Additional meetings, webinars and calls will be scheduled as needed.

The first workshop was held January 8 - 9, 2020 and focused on the program goals and objectives. Approximately 80 people attended in person or on the phone/webinar over the 2-day workshop. The attendees suggested edits to the goal statements and provided additional objectives. Staff incorporated the changes into a revised draft document, which was emailed to the addendum Part 1 mailing list and posted on the Council's website. There is still work in progress on some of the objectives, and those additions and edits will be incorporated into the document when available.

Two strategy performance indicator workshops have also been held, one on strategy performance indicators for salmon and steelhead and one on strategy performance indicators for white sturgeon. Staff incorporated the additions and edits from those workshops into the revised draft document, which was again emailed to the addendum Part 1 mailing list and posted on the Council's website. Three additional workshops will be held prior to the March Council meeting.
