### **BACKGROUND:**

**Summary:** In 2019, Governor Inslee committed to updating the "Statewide Salmon"

Strategy – Extinction is not an Option" which was completed 20 years ago under former Washington Governor Gary Locke. The Strategy was formed at the time to address the listing of salmon under the federal Endangered Species Act. This unique strategy created a collaborative initiative to restore and protect salmon runs across Washington by convening a group rooted in local expertise, experience, partnerships, and on-the-ground leadership. Over the last 20 years, there have been significant advances in salmon recovery through regionally specific, scientifically rigorous, and locally produced recovery strategies. Partnerships have matured and Washington has seen some success with some species showing signs of recovery, yet some runs continue to decline. The goal of this effort is to bring statewide salmon strategy up to date while honoring the achievements and investments made over the last 20 years. Social, political, and physical landscapes have changed; rededicating energy toward this effort includes acknowledging necessary improvements, new approaches, and new perspectives to protect and restore this statewide legacy and to put all salmon runs on the road to recovery. The Governor's office, the Governor's Salmon Recovery Office and WDFW are currently

503-222-5161 800-452-5161 Fax: 503-820-2370 convening and gathering input from important stakeholders across the state to soon begin drafting recommendations to the Strategy Update. The Strategy Update will include a review from the Natural Resource Cabinet agencies and a public comment period. The final Statewide Salmon Strategy Update is expected to be completed in late 2020.

**Background:** The Washington Legislature has provided funding to identify gaps in the current strategy, based on the regional recovery plans, court decisions, National Marine Fisheries Service's five-year review and data needs, Treaty obligations, the Governor's Orca Task Force recommendations, and other emerging priorities

In May of 1997, Governor Gary Locke and agency heads signed a memorandum agreeing to establish a forum to serve as the "...formal and ongoing institutional framework to promote interagency communication, coordination and policy direction on environmental and natural resource issues." This Joint Natural Resources Cabinet included both Washington members of the Northwest Power and Conservation Council, Ken Casavant and Mike Kreidler.






